



Benefits Terms and Conditions

for the SAS Executive Card

These Benefits Terms and Conditions apply to the benefits made available in connection with the SAS EuroBonus Business Cards program and form part of the [SAS EuroBonus Business Cards Terms & Conditions](#). Capitalised terms not defined here have the meaning given in those Terms and Conditions. In the event of a conflict, the SAS EuroBonus Business Cards Terms and Conditions prevail, unless these Benefits Terms and Conditions expressly state otherwise for a specific Benefit.

Benefits are available only while the relevant Card, Customer participation and, where required, linked EuroBonus Account remain active and eligible. Benefits may be provided by SAS or a third party and may be subject to additional provider terms linked below. Eligibility, allocation and use are subject to the applicable Card Product and to the limitations set out below.

EuroBonus Bonus Points

The Cardholder earns 25 EuroBonus Bonus Points for every SEK 100, NOK 100 or DKK 100 of eligible spend. Transactions made in other currencies will be converted into the Card's applicable billing currency for the purpose of calculating EuroBonus Bonus Points.

EuroBonus Bonus Points are calculated monthly and credited after the Customer has paid at least the minimum amount due under the relevant invoice. If that amount remains unpaid following the Creditor's second payment reminder, the related points will be forfeited and will not be credited, reinstated or compensated, even if payment is subsequently made.

Eligible spend excludes cash withdrawals, fees, interest, charges and any other transactions designated as ineligible by SAS. Reversed, refunded or cancelled transactions do not qualify, and points previously credited for such transactions may be withdrawn or corrected.

SAS may from time to time introduce or amend a limit on the eligible spend for which EuroBonus Bonus Points may be earned during a specified period. The applicable limit and calculation period for each Card Product will be communicated by SAS. Temporary welcome offers and promotional campaigns are subject to their separate campaign terms.

EuroBonus Bonus Points are otherwise administered in accordance with the [EuroBonus Member Terms and Conditions](#), including rules on crediting, correction, withdrawal, expiry and misuse.



Unless otherwise agreed in writing between SAS and the Customer, the above allocation applies.

EuroBonus Level Points

The Cardholder will receive 20,000 EuroBonus Level Points per card year for an eligible SAS EuroBonus Business Card.

The first allocation is made following activation of the eligible Card. A further 20,000 EuroBonus Level Points are allocated on each annual card anniversary, provided that the Card remains active and eligible and is still linked to the Cardholder's EuroBonus Account. Allocation is subject to reasonable processing time and technical and operational dependencies.

A Cardholder may have only one Card at a time linked to the Cardholder's EuroBonus Account for earning EuroBonus Bonus Points and EuroBonus Level Points. Holding or applying for another Card, through the same or another Customer, does not create an additional or renewed entitlement to Level Points for the same card year. EuroBonus Level Points are otherwise governed by the [EuroBonus Member Terms and Conditions](#).

Unless otherwise agreed in writing between SAS and the Customer, the above allocation applies.

SAS Lounge Access

Eligible Executive Cardholders aged eighteen (18) years or older receive ten (10) SAS Lounge Vouchers per card year. Only the one Card linked to the Cardholder's EuroBonus Account for earning EuroBonus Bonus Points and EuroBonus Level Points provides access to this Benefit.

To receive and use Lounge Vouchers, the Cardholder must remain an active EuroBonus Member, have the SAS App installed and be logged in to the EuroBonus Account linked to the eligible Executive Card. Vouchers are issued, accessed and redeemed through the SAS App.

Each Lounge Voucher provides access for one (1) person on one (1) occasion. The Cardholder may use vouchers for themselves or individual eligible travellers in the same booking and may select which traveller(s) will use the voucher(s).

Lounge Vouchers may be used at eligible SAS Lounges at Stockholm Arlanda (ARN), Copenhagen (CPH), Oslo (OSL) and Gothenburg Landvetter (GOT), subject to opening hours, capacity and applicable entry requirements.



Lounge Vouchers are valid only for scheduled departures operated by SAS. They are not valid for arrivals, charter flights or flights operated by another airline, including codeshare flights marketed by SAS but operated by another airline.

Ten (10) Lounge Vouchers are issued following activation of an eligible Executive Card and a further ten (10) are issued on each annual card anniversary, provided that the Card remains active and eligible. Unused vouchers expire when the next annual allocation is issued and do not carry over. If the Card is cancelled, suspended, expires or is no longer linked as required, unused vouchers become unavailable.

Once activated, a Lounge Voucher is considered used and cannot be cancelled, refunded, replaced, exchanged or reinstated. No refund, replacement or compensation will be provided for an activated voucher that is not used, including due to lounge capacity restrictions, denied entry, flight cancellations, missed connections, schedule changes or other travel disruptions.

Lounge Vouchers cannot be combined with other lounge access offers, vouchers, promotions or products, unless otherwise specified by SAS.

Lounge access is subject to applicable SAS Lounge terms and conditions. For questions or issues relating to Lounge Vouchers, Cardholders should contact SAS customer support through the support channels provided in the SAS App.

Priority Pass

Eligible Cardholders may enroll in Priority Pass through the SAS EuroBonus Business Card App. Priority Pass membership is provided by Nordiska in partnership with Mastercard.

Access rights, participating lounges and usage conditions are governed by Priority Pass and may change without notice.

Executive Cardholders receive five (5) Priority Pass Lounge Vouchers per card per year. The first allocation of five (5) vouchers is made following activation of an eligible Executive Card, and a further five (5) vouchers are allocated on each annual card anniversary, provided that the Card remains active and eligible. Allocation is subject to reasonable processing time and technical and operational dependencies.

Each voucher provides access to one (1) person on one (1) occasion. Vouchers are valid only until the next annual card anniversary and do not carry over. Additional visits may be purchased at a discounted rate of USD 35 per visit, which will be charged to the Card.

NordVPN

Eligible Cardholders may activate NordVPN through the SAS EuroBonus Business Card App. The NordVPN subscription is provided by Nordiska in partnership with NordVPN and is subject to NordVPN's applicable Terms of Service.

The subscription is included for as long as the Executive Card remains active and provides access to NordVPN Basic, including high-speed VPN protection across up to 10 simultaneous connections, access to servers in 126 countries, and basic ad and malicious domain blocking.

The benefit is intended to support secure internet access while travelling for business purposes.

SAS B2B eSIM

Eligible Cardholders may claim 3 GB of mobile data each calendar month for use in more than 100 destinations across six continents. No local SIM card or advance selection of destination is required.

The monthly data allowance expires at the end of each calendar month and any unused data does not carry over to the following month. Activation, supported destinations, compatible devices, network availability and use of the service are subject to the applicable SAS B2B eSIM terms and conditions.
